

## Privacy Policy

This Privacy Policy (“Policy”) explains in detail how Orange House (“Company”, “we”, “us” or “our”) collects, uses, discloses, and safeguards information in connection with LangersGPT, our websites, educational content, and related services (collectively, “Services”). By accessing or using our Services, you agree to be bound by the terms set forth below. This Policy has been prepared in accordance with the applicable laws of the Government of India, including the Information Technology Act, 2000, the IT Rules, 2011, and any subsequent amendments or guidelines issued by Indian regulatory authorities.

### 1. Definitions

For the purposes of this Policy, the following definitions apply:

- “Personal Data” means any information that relates to an identified or identifiable individual, as understood under the IT Act, 2000 and related guidelines.
- “Sensitive Personal Data or Information (SPDI)” includes financial details, health information, biometric data, and any other information that requires enhanced protection.
- “Anonymous Data” refers to data that has been anonymized such that the individual cannot be identified from it.
- “Processing” means any operation or set of operations performed on Personal Data, whether automated or manual, including collection, storage, retrieval, use, disclosure, and deletion.
- “Service” or “LangersGPT” refers to the AI-powered educational tool offered by Orange House.
- “User” or “you” means any individual accessing or using our Services.

### 2. Introduction and Scope

This Policy describes how we process both Personal Data and Anonymous Data through the use of our digital platforms, including websites, mobile applications, and other interfaces where the Service is available. This Policy is an essential component of our Terms of Service and is intended to comply with all applicable data protection regulations under Indian law, ensuring transparent and responsible data handling practices.

### 3. Data Collection Practices

#### 3.1 Types of Data Collected

We may collect information in the following categories to support the educational goals of our Service:

- Usage Data: Information such as learning activity logs and interactions with the Service, collected in anonymous or aggregated form for the purposes of personalizing content and improving our offerings.

- **Non-Personal Data:** Data that cannot be associated with a specific individual, used solely for statistical analysis and service improvement.

### 3.2 Methods of Collection

Data may be collected through:

- **Direct Input:** When users register for an account or interact with our Service.
- **Automated Tracking Technologies:** Such as cookies, web beacons, and similar tools, deployed in accordance with the guidelines under the IT Act, 2000.
- **Third-Party Integrations:** Data may also be received from authorized partners or educational institutions, ensuring that such data sharing complies with Indian legal norms.

### 3.3 Data Minimization

We are committed to the principle of data minimization and collect only the data necessary to provide an effective educational experience while adhering to the guidelines and limitations prescribed by Indian law.

## 4. Use of Data

### 4.1 Educational Enhancement and Service Improvement

The collected data is used strictly for the following purposes:

- Customizing and personalizing educational content based on users' interactions with the Service.
- Conducting anonymous analysis to enhance system functionality and user experience.
- Improving website and application performance by tracking usage patterns.

### 4.2 Legal and Regulatory Compliance

In addition to service improvements, we process data to comply with legal obligations imposed by the Government of India. These include responding to lawful requests or regulatory requirements under the IT Act, 2000 and applicable IT Rules.

### 4.3 Prohibited Purposes

We expressly prohibit the use of any collected data for targeted advertising, commercial profiling, or marketing purposes without obtaining explicit consent from the user, unless otherwise mandated by law.

## 5. Children's Privacy

### 5.1 Special Protections for Minors

Our Services are designed to support users of all age groups. However, for children (users under the age of 18), we exercise heightened care in data handling. We do not intentionally collect any Personal

Data from minors unless it is required for educational purposes and accompanied by appropriate parental or guardian consent, in compliance with Indian guidelines.

## **5.2 Compliance with Indian Regulations**

The privacy practices applicable to minors are aligned with the provisions of the IT Act, 2000, and any future statutory rules developed by Indian authorities governing data protection for children.

## **5.3 Advertising and Content for Minors**

No advertising or promotional content that contravenes the safety standards prescribed for children is displayed or targeted at users under 18. All educational content is rigorously reviewed to ensure it meets safety and ethical standards.

## **6. Data Protection and Security Measures**

### **6.1 Security Protocols**

We implement robust technical and organizational measures to protect Personal Data against unauthorized access, alteration, disclosure, or destruction. These measures include:

- Use of encryption technology for data transmission and storage.
- Implementation of strict access controls and authentication mechanisms.
- Periodic security reviews and audits in line with the best practices under Indian cyber security guidelines.

### **6.2 Incident Response and Breach Notification**

In the event of a data breach, we shall initiate our Incident Response Plan to investigate, contain, and remediate the issue. In compliance with Indian regulatory requirements, any data breach involving Personal Data will be reported to the appropriate authorities and affected users will be notified promptly.

## **7. Disclosure to Third Parties**

### **7.1 No Unauthorized Sale or Sharing**

Orange House does not sell, trade, or transfer any Personal Data to third parties for commercial purposes. Any data provided to external parties is either anonymized or provided in aggregated form.

### **7.2 Service Providers and Partners**





We may share data with trusted third-party service providers who assist with system maintenance, analytics, or educational content delivery. Each such party is contractually bound to maintain data confidentiality and to adhere strictly to the security practices mandated by the Government of India.

### **7.3 Legal and Regulatory Disclosures**

Should it be required by law or by a valid legal process under Indian law, we may disclose Personal Data to governmental authorities or as necessary to enforce our legal rights.

## **8. User Rights and Control**
